681 Present; Cllrs Fry, Gillott, Kerley (Chairman), O'Keefe, Smith and Taylor, clerks (Mrs C Churchill and Mr L Fry) and 2 members of the public.

684 Minutes of meeting dated 15th July 2008, were approved with three amendments;

673. Cllr Smith. stated that Clerk is paid in arrears, so Sept payment will include August and Sept.

Cllr Smith proposed amended minutes are signed, Cllr Taylor 2nd, all in favour.

685 Arrangements for presentation of Best Kept Village Awards on Sunday 5th October 2008. This will take place on October 5th at 10.30am. Chairman to receive all awards but all cllrs are requested to be present. If Chairman is unavailable, Vice-Chair will accept awards. Clerk to invite parishioners involved in tidying up the village but ALL PARISHIONERS are welcome to attend.

Pole and shield needs to be collected from Mildenhall, Cllr Kerley to arrange, Clerk to arrange insurance of pole and shield.

To be erected on the Green by the shop, Clerk to check with highways.

Also need a Union Jack, D Cllr Parker has offered the use of one.

Celebration afterwards, Cllr Gilliot will arrange coffee and biscuits (preferably in the hall). Cllr Taylor will ask WI to do a flower arrangement.

Cllr Taylor to ask Village Hall if certificates can be displayed permanently on the walls.

686 Brief report on upcoming consultation for SDC's Core Strategy. Cllrs Fry and Kerley attended, Cllr Fry gave a brief report. This is SDC's latest update to the local plan and covers next 5 yrs. Consultation document is much smaller, easier to digest and Dinton does not feature. Cllr Fry will display the SDC poster advertising the exhibition dates, Wilton exhibition is on September 8th.
