

DRAFT MINUTES OF A MEETING OF FOVANT PARISH COUNCIL HELD ON 1st March 2016 IN THE VILLAGE HALL.

Present Cllrs Dunn, Havard, Holmes (Chairman), Mrs Jones, Phillips, Swift and Mrs Turner.
In attendance; Mrs C Churchill (Clerk). Wiltshire Cllr Mrs Green and 21 members of the public.
Apologies PCSO Huntley

Questions or statements from members of the public on any matter concerning the village.
Simon Davies – Sutton Rd. It was a shock to find a surveyor in the field off Sutton Rd, further investigation found that the Rural Housing Needs Survey (2012) had identified a need for 7 properties in the parish.

Are there brownfield sites within the village boundary?

Have efforts been made to look for brownfield sites.

Core strategy states that clear support from the local community is required.

Cllr Holmes asked Mr Davies not to seek parish support at a parish council meeting, he was welcome to call his own public meeting.

Nigel Knowles – Brook St. There have been 2 surveys on affordable housing and both have shown a need for affordable homes. Land in the village has previously been looked at.

This is an opportunity for the village to get affordable housing.

Affordable housing may be built on exception sites, drainage may be a problem but the parish should not throw the offer away.

There is a need for a Parish Plan, 2 previous attempts failed but would be willing to be part of a steering group. There has been recent AONB funding for parish plans.

Howard Smith, representing the Landowner. The land was purchased in 2002 subject to an option agreement, if Wiltshire Council decides to take up the option then they will pay £1 for the land.

The site is larger than the need requires, unsure if Wiltshire Council intend to develop the whole site.

Quoted Core Policy 44 of the Core Strategy. It is important that Fovant PC understand the policy
Feel the development will be a minimum of 10 houses.

Site is not ideal for additional development.

Report from the Tisbury Neighbourhood Police Team. Apologies had been received.

Only two reports in the last month;

29/01 A vehicle appeared abandoned and parked poorly in Sling Orchard. It was not causing an obstruction and there were no further calls so no police action taken.

04/02 Nottingham knockers. Wilton NPT dealt as I wasn't on duty. The male had already left the area and security advice was given to the caller. Please call on 101 and we will check out any unsolicited callers and advise them to leave area.

Report from Wiltshire Councillor Mrs Jose Green.

The current position is in Wiltshire regarding Fracking is.....

There are 4 blocks in Wiltshire and licences from the OIL and Gas Authority (OGA) have been approved. These 4 sites are at Chitterne/Imber Range, Warminster/Longleat, Trowbridge/ Westbury and Erlestoke. Before a Licence becomes operational further permissions and consents need to be applied for.

These include Planning Permission, Environmental permits, Health and Safety Executive and further

drilling operations from the OGA.

WC has received NO planning applications or had any pre- application consultations from the Licensee to date.

The AONB's and National Parks and Sites of Special Scientific Interest (SSSI's) are 'protected areas' so any impact on these sites would require consent from Natural England.

I am receiving a good number of representations on the subject.

WASTE FLY-TIPPING is an offence, with a maximum penalty of £50,000 fine or/and 12 months imprisonment.

For small scale tipping a Fixed Penalty Notice (currently £75) can be issued plus legal costs and compensation.

House holders and Businesses must understand their obligation to dispose of their waste legally.

Always check that your rubbish is only passed on to Authorised Waste Carriers. If it is traced back to the householders address THEY could be prosecuted or fined for breaking the law. Always ask to see their Waste Carrier Licence, if they don't have one, don't use them!!

Call the Environment Agency 03708 506 506 for an instant waste carriers validation check or go online.

Keep a record of any paperwork they give you, dates, name and telephone number. Report anyone who is not registered to the Environment Agency. 03708 506 506.

It costs us Council Tax payers a huge amount every year tidying up after those who chose to abuse the law.

Cllr Holmes opened the meeting at 7.17pm

15/188. There were no apologies for absence.

15/189. Council meeting minutes - to confirm and sign the minutes of the parish council meeting held on 2nd February 2016.

Fovant PC resolved to approve the previously circulated Minutes without amendment and they were signed by the Chairman.

15/190. Declarations of Interest.

Cllr Swift had submitted a dispensation requesting to speak on agenda item 15/191. Cllr Swift lives in Home Close but does not share a boundary with the site identified.

Fovant PC resolved to approve the request, allowing Cllr Swift to speak on the site in Sutton Rd, this will expire on the day of the next election in 2017.

Cllrs Phillips and Swift declared an interest in planning application 16/ as they were both involved with Fovant Badges Society.

15/191. To respond to Wiltshire Council on the land south west of Home Close, Sutton Rd which has been identified for potential development.

Mr Andrew Mead (AM) from WC, spoke to Fovant PC.

The land at Sutton Road is currently the only land under consideration and this is only in project initiation stage.

Fovant PC withdrew support of the Rural Housing Needs Survey (RHNS) prior to the survey taking place, do WC wish to have an open discussion?

What about the suitability of the site.

The timescale for response in the initial email was too short and not clear, what is Fovant PC agreeing to?

Fovant PC would like to work with WC.

AM – affordability is the key and the site is affordable.

Drainage can be sorted.

Site marked on plan sent with email is approx. 2 acres.

AM – unaware of any intention for market value housing.

Engineering costs may make the site unaffordable.

A recent report by the Town and Country Planning Association was read out, it states that starter homes should be included in affordable housing.

AM – currently there is no Govt legislation re delivery of started homes. WC will consider shared ownership. Shared ownership is when the tenant can purchase a certain amount of the property and pay an affordable rent on the rest.

Affordable housing for local people, what is that? A 2 bed affordable home in Tisbury is £250,000.00

AM – affordable housing isn't an open market, the house must have a value to WC. To apply for affordable housing prospective tenants / owners must be on the Homes for Wiltshire register.

Local people, it would be nice to be for people from the village, what evidence is there for ensuring locals get the housing being delivered?

AM – housing for local people but need to ensure parishioners are registered on the Homes for Wiltshire register.

Would like to see the data of how many people in exception sites are local. What proportion of "affordable" houses for "local" people in the Tisbury Community Area are currently occupied by residents who moved there from within that parish.

Would WC own the houses or would they be passed onto a Housing Association?

What about Right to Buy?

AM – can't avoid the Right to Buy. WC intend to manage the site, ownership is subject to legal agreements. Will send information on Right to Buy.

Currently there is no bus service for people working out of the parsh.

Can sites be brownfield / greenfield etc?

(i) Do Fovant PC support the use of the existing data from the RHNS 2012?
Fovant PC resolved to support the use of the existing data from the RHNS 2012.

(ii) Is there a desire within Fovant for Affordable Housing within the Parish?
Fovant PC resolved to support actual affordable housing for actual local people.

8.07pm. Cllr Dunn left the meeting.

(iii) Should Affordable Housing be supported within the Parish, at what location would it be supported? *Please note that the Parish Council can not put sites forward without consulting the landowner.*

Fovant PC was unable to answer this. To be discussed at the May meeting.

To resolve whether to call a public meeting to discuss the provision of affordable housing.

Fovant PC resolved that the matter should be discussed at the Annual Parish Meeting.

Andrew Mead offered to attend the Annual Parish Meeting on 5th April.

Fovant PC thanked Mr Mead and accepted the offer to attend.

Fovant PC thanked Mr Mead for attending, Mr Mead left the meeting.

15/192. Chairman's announcements. There were none.

15/193. Exclusion of the press and public. None required.

There was no one present to co-opt.

15/196. To respond to Wiltshire Council's transport consultation. A consultation is being run on all subsidised bus routes in the county. The following buses are listed as being subsidised, 25/26/27.

Fovant Parish Council resolved to send the following comment Clerk
"rural areas require buses, not all those living in rural areas can drive or have access to a car so transport is essential in rural areas".
