0342. Gully on High St by A30 junction. The cost of changing the gully to one with a cycle friendly cover is £400 which may require a minimum 25% contribution from Fovant PC although as Highway work Fovant PC feel no contribution is necessary.

To authorise this funding of £100 should it be a requirement to complete the work.

If a contribution is required to ensure the work proceeds then Fovant PC will contribute no more than 25%.
