DRAFT MINUTES OF A MEETING OF FOVANT PARISH COUNCIL HELD ON 7th July 2015 IN THE VILLAGE HALL.

Questions or statements from members of the public on any matter concerning the village.

- Now that the website is up to date, it may be worth alerting parishioners via the Three Towers that the website has been updated.
- There have been two occasions in the last few weeks where signs have been displayed advising of an A30 closure, the road was not closed on either occasion. This is not acceptable.

It was explained this closure was still covered by the road closure authorised in 2014 and that the contractor had displayed the signs before getting permission and had been requested to remove them ASAP.

Report from the Tisbury Neighbourhood Police Team. Apologies received.

Report received from Wiltshire Councillor Mrs Jose Green.

- There are now 68k households signed up to the Garden Waste collections.
 From 13th July the HRC (Household Recycling Centre) at Churchfields will be open 5 days per week from 10am 4pm. (Friday, Saturday's, Sunday, Monday and Tuesday's.) Friday, Saturday and Sunday's have always been the most popular days for the public to take their surplus, so hopefully it won't cause too much inconvenience. It might be useful to check on the website before leaving home.
- The cut back on the verges is in full swing but has highlighted the litter problem. Some villages are having a Community Litter pick up day. Details of this has been circulated to the Clerk.
- Diabetes UK are touring Wiltshire during July. As part of the Public Health programme the NHS
 Health check vehicle will be in the Market Place, SALISBURY for 40yrs- 70yr olds to have a
 diabetes test. The aim is to raise awareness and therefore prevention.
 In Wiltshire alone there are 21 thousand people diagnosed with an estimated further 7 thousand
 undiagnosed. 90% are Type 2.

Please note that the HRC at Churchfields will be closed on Thursday and Friday.
