THE SWALLOWCLIFFE VILLAGE PLAN 2010

"If things are to remain the same, they have to change"

What is the Village Plan, and what is it for?

- **1.1** The Village Plan provides a set of development principles for the village, backed by specific objectives, to assist the Parish Council (PC) to run and guide the village on behalf of its villagers within the framework of local government in Wiltshire, now a single unitary authority.
- **1.2** It is a public document, reviewed annually at the Village Annual Meeting in April, which:
 - 1.2.1 Gives all villagers the opportunity to contribute their ideas and opinions to the way the village is run;
 - 1.2.2 Gives the PC a set of background principles against which to make decisions in the interests of the village;
 - 1.2.3 Establishes the foundation for a position to bid for funding and work within the developing system of unitary local government in Wiltshire through Area Boards and Community Partnerships;
- **1.3** It draws on a range of published policies and strategies at Wiltshire Council level to set them in the context of Swallowcliffe and its particular needs. The South Wiltshire Core Strategy and the Swallowcliffe Village Design Statement provide the necessary full background detail on planning matters.
- **1.4 Why do we need it?** We live in a small village which is now within the wider framework of unitary local government with many powerful players. Also, for the foreseeable future, funding for local government will be at a premium. As villagers, we need to be clear as to what we need and want, to ensure our voice is heard, and also to be positioned properly to take advantage of events as they unfold. In short, it is a means of "sorting the wood from the trees", so that the Parish Council can pursue the issues that matter to the village and its villagers. It does not, and indeed cannot, "tick off" every conceivable issue that might arise. Rather, it is a first reference when addressing issues and assessing performance, and providing some foundation criteria for decisions on behalf of the village

Strategy – what do we want our village to look like over the next 10 years?

- 2.1 Four essentials stand out:
 - 2.1.1 Community. Maintaining an active community with a balanced cross section of age groups – this means attracting younger people and providing for them in terms of housing and amenity, as well as relying upon established practice;
 - 2.1.2 Village Character. Maintaining the character of our village through sympathetic development this mean encouraging building development that is in keeping with that we already have;
 - 2.1.3 Infrastructure. Improving infrastructure and amenity to keep abreast of developments elsewhere, for example, high speed internet connection this

- means keeping up the pressure through the South West Wiltshire Area Board and others to ensure rural areas get a fair share of development effort; and,
- **2.1.4 Local Services**. Providing sufficient resources to sustain essential services this means ensuring that the village gets a fair share of maintenance resources for highways, waste removal and so on.
- **2.2** These essential objectives provide the context for judgements that affect the running of the village, in particular, planning decisions and budgetary decisions; and, the basis for priorities in the medium term.

Priorities

3.1 Within each category, there are criteria for action and decision making, and some short term priorities for the management of the village. The categories are laid out below: separate pages are used for ease of use. Both the criteria, and the priorities, reflect public consultation with Swallowcliffe Villagers at a public meeting held on 24 June 2010.
